The AWP does not have Outputs though from the indicators outputs could be produced/determined. The AWP has been drafted in a Log-frame (Logical Framework) way. Type of expenditures for goods, works, consultancies, operating costs are outlined in the AWP. The activities have linked to DLIs.
2	Activities and outputs aligned with priorities and contribute to the achievement of results and DLIs.	Yes, the activities and outputs are aligned with priorities and contribute to the achievement of results and DLIs.
3	Within budget though frontloading in the early years may be encouraged.	There is frontloading of budget for AWP for ACEESD for 2018/19 with a total budget of \$1,109,033.
4	Works to stay within 25 percent of overall ACE budget.	 There is \$75,000 to set up a Micro-grid laboratory which is 6.8% of the total AWP budget for 2018/19.
5	Procurement of vehicles to be reasonable (one vehicle and one van maximum per ACE)	 The AWP has no item and budget for the procurement of vehicles. However, the ACE will be hiring a car with a budget of \$7,270 which is reasonable.
6	Staffing support cost to be reasonable, and capacity building or staff development and training included	There are staffing costs for salaries for ACEESD staff (Admin. And support staff) in the amount of \$130,969.
7	Partnership cost may deserve a more careful review (overall within project, it must be 15% of total)	 The budget invested in national, regional and international partnerships is \$84,224 which is 7.8 % of total AWP budget. It is recommended to show how ACEESD as an ACE will be governed and how the partners are involved in decision making and oversight of management. It is also recommended to put more budget in partnership activities, and provide details of each budget lines in relationship to the outputs.
8	AWP should have attachments: 1) procurement plan,	The AWP has the following: (i) Procurement plan

	2) staff development plan 3) any relevant plan for the new course development (i.e. market survey, consultation, standards, technical workshop, review by university senate, etc.)	•	(ii) Staff development plan The Center will not develop any new courses for 2018/19 The AWP has a plan for attracting Academic Staff and students from the region which include branding and advertising.
9	Any "big cost" items, which will require extra TA from RFU and WB (i.e. accreditation, program development, partnership, main civil works, procurement of labs, etc.)	•	The "big cost" is \$453,988 for setting up the Energy Laboratory Equipment/Second phase.
10	Other items in the AWP that need attention.	•	Overall it is a well written AWP. However, a consideration could also be made for inclusion of the following: (i) Outputs of the activities in the AWP. (ii) Need for more activities and budget with partnerships with national, regional and international partners from both public and private sectors attracting national and regional students. (iii) Plan for more activities for academic staff development as a major incentive to ACE staff.
